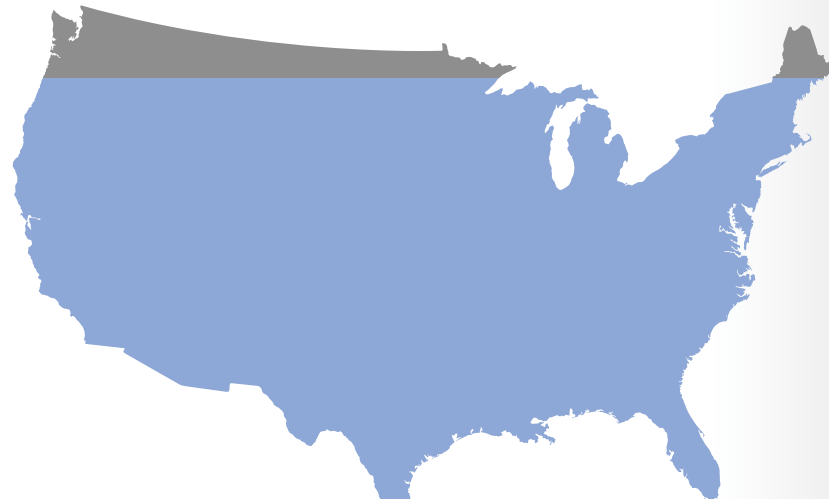

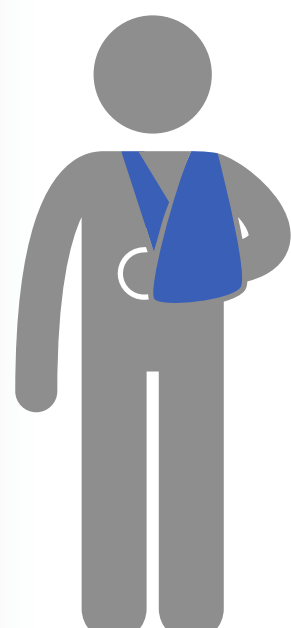

## WHAT SHOULD I DO AFTER BEING INJURED AT WORK?



**1. SEEK MEDICAL ATTENTION**  
as soon as possible



**2. NOTIFY YOUR EMPLOYER**  
of an accident or injury



**3. REQUEST AND FILE THE  
PROPER PAPERWORK**  
with your employer



**4. Be sure to  
KEEP COPIES OF  
ALL PAPERWORK**



**5. SPEAK WITH AN  
EXPERIENCED WORKERS'  
COMP LAWYER**  
to discuss your rights
